Living with Motion Chiropractic is required by law to maintain the privacy and confidentiality of your protected health information.

DISCLOSER OF YOUR HEALTH INFORMATION

- Treatment We may disclose your protected health information to doctors, hospitals, and other healthcare professionals for their provision, coordination, or management of your health care and related services.
- Payment We may disclose your protected health information to insurance providers for the purpose of payment or healthcare operations.
- <u>Workers' Compensation</u> We may disclose your protected health information to comply with State Workers' Compensation Laws.
 <u>Emergencies</u> We may disclose your protected health information to notify or assist in notifying a family member, or another person responsible for your care about your medical condition or in the event of an emergency or of your death.
- <u>Public Health</u> As required by law, we may disclose your protected health information to public health authorities for purposes related to: preventing or controlling disease, injury or disability, reporting child abuse or neglect, reporting domestic violence, reporting to the Food and Drug Administration problems with products and reactions to medications, and reporting disease or infection exposure.
- <u>Judicial and Administrative Proceedings</u> We may disclose your protected health information in the course of any administrative or judicial proceeding or in response to a legal order.

The chiropractic doctor provides a specialized, non-duplicating health care service. Your doctor of chiropractic is licensed in a special practice and is available to work with other types of providers in your health care regimen.
